



Stubble fires down by 57 pc in last 2 yrs By Ajay Bhardwaj

aryana has been pursuing a comprehensive strategy to combat the menace of stubble fires following which there has been 38% reduction in stubble burning incidents in 2023 compared to the previous year.

Last two years put together saw a substantial 57% reduction in the straw burning incidents. Meanwhile, the state government has issued instructions to hold Deputy Commissioners and police Station House Officers accountable for not controlling the fire incidents. The government has also taken strict actions against individuals responsible for farm fires, issuing 1256 challans with fines totaling over Rs. 32.55 lakh and filing 72 FIRs related to farm fires and a total of 44 farm fire instances were extinguished. Recently, the Haryana government adopted the "Haryana Ex-Situ Management of Paddy Straw Policy 2023" which is aimed at harnessing paddy straw for sustainable energy and eliminating crop residue burning by 2027. The policy provides a framework for attracting private investment in paddy straw-based projects while encouraging farmers to engage in responsible practices, establishing a robust linkage between farmers and industries. Come Jan 1, pension will be Rs 3,000

sserting his unwavering commitment to the cause of inclusive development at the historic Antyodaya Mahasammelan organized in Karnal mark the 57th anniversary of Haryana's formation, Chief Minister Mr Manohar Lal made a key announcement for the beneficiaries of social pensions, a testament to the state government's resolve to transform the lives of its people.

Chief Minister Mr Manohar Lal in the august presence of Union Minister for Home and Cooperation announced that from January 1, 2024, beneficiaries of social pensions in the state will receive a monthly pension of Rs 3,000, a significant increase from the current Rs 2,750. "In the past nine years, we have left nothing unturned in giving a new shape to the state's developmental journey," said Mr Lal while addressing the mammoth gathering.

years ago, during the tenure of previous governments, Haryana grappled with a stifling atmosphere marked by disappointment and favouritism, where emphasis on caste and class distinctions reigned, our government prioritized public welfare. However, people in the Opposition still talk about caste-based politics. All parties are making announcements to appoint Deputy Chief Ministers from different castes. We stand against caste-based politics." "The government's initiatives speak volumes about their dedication to the welfare of the citizens. Implementing numerous schemes tailored to address the challenges faced by the underprivileged, we have effectively used information technology to ensure that the benefits of these programs reach grassroots levels," said Chief Minister Mr Manohar Lal.

The Chief Minister said that the Congress has always chanted the slogan of eradicating poverty. Sometimes they ran programs based on four principles, sometimes on twenty principles.

In reality, they kept playing a deceitful game with the poor. But now, the public won't be swayed by their deceit, he said, adding that "we worked to implement all the schemes of the central and state governments for their welfare."

Highlighting his government's 3C strategy, Chief Minister Mr Manohar Lal said that his government has worked to eliminate the 3Cs-caste-based politics, corruption, and crime. He said that the present state government has worked on 7S - Education, Health, Security, Self-Reliance, Self-Respect, Good Governance and Service and will continue to do so. The government's treasury is open for the welfare of the poor, and we will not let any shortage of funds occur, said the Chief Minister, adding that the present state government has decided to give an additional 5 per cent quota to the youth from poor families so that they can also enter government jobs.

With the shower tap kept running, the ranks of those who have their Diwali made brighter and sweeter continues to swell by the day. Haryana Review makes an attempt to slice and dice the announcements made up to November 9, 2023, including those to mark the 58th Foundation Day of Haryana, to bring our readers their import and impact. Let's begin with the latest.

Honorarium of SPOs raised to Rs 20,000

Making a Diwali gesture, the Chief Minister, Mr Manohar Lal, has increased the honorarium paid to the Special Police Officers (SPOs) engaged in the safety and security of our Haryana residents, from Rs. 18,000 to Rs 20,000 per month. The decision announced on November 9 will benefit about 9,000 SPOs in the state.

They will get Rs 501 for **Diwali sweets**

Safai karamcharis, chowkidars and tubewell operators across Haryana have their Diwali made sweet by the Chief Minister, Mr Manohar Lal. He announced on November 7 a special Diwali gift of Rs 501 for safai karamcharis (both rural and urban); chowkidars (both rural and urban), and tubewell operators. The money for Diwali sweets will be directly transferred into their accounts.

Sugarcane price raised by Rs 14 per quintal

Diwali came six days in advance for the sugarcane growers in Haryana. Living up to the reputation of the state paying the highest price to sugarcane growers, the Chief Minister, Mr Manohar Lal, announced on November 6, 2023 a hike of Rs 14 per quintal, from Rs 372 to Rs 386. This decision will benefit lakhs of farmers who will be rewarded for their hard work.

What's more, he also hinted at





2,750 to Rs 3,000 per month and 4 percent increase in DA paid to the staff and pensioners.

The hike in old age pension from January 1, 2024 and 4 per cent increase in DA from July would benefit close to 23 lakh people in the state.

While the increase in old age pension will benefit more than 18.5 lakh senior citizens-more than Rs 500 crore is paid every month on this account-the hike in DA would benefit 3.5 lakh employees and more than 1.5 lakh pensioners in the state.

Expanding its scope of the Ayushman/ Chirayu Scheme, the Chief Minister announced the decision to extend coverage to families with annual income of Rs 3 lakh. Hitherto, it was confined to families with an annual income below Rs. 1.8 lakh.

This decision to extend the scope will benefit an additional 38,000 families. With the inclusion of 14 lakh new families, about 40 lakh Antyodaya families in Haryana are benefiting from the Ayushman Bharat-Chirayu by combining the central and state government's schemes.

Under the Central Government's Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana, 15 lakh families receive free annual treatment of up to Rs 5 lakh. Until November 2, about 11 lakh families had benefited from the Chirayu scheme of Haryana Government.

1,340 diseases 569 across across empanelled hospitals Haryana. In the initial phase, 894 employees from the Fisheries and Horticulture Departments were covered for 1,055 diseases in 305 hospitals. The plan is to take the cover to other departments within the state.

Civic bodies: two-fold hike in honorarium

Members of municipal corporations, municipal councils and committees have reason to cheer! On the occasion of the ninth anniversary of his government, the Chief Minister announced a significant increase in their honorarium, making it a gift on the occasion of Diwali.

There are currently 87 municipalities under the Local Bodies Department, including 10 municipal corporations, 19 municipal councils and 58 municipal committees in the state. The increased honorarium will be applicable with effect from October 1, 2023. Mayors receive a monthly honorarium of Rs. 20,500, which has now been increased to Rs. 30,000. Similarly, Senior Deputy Mayor's honorarium has been increased from Rs. 16,500 to Rs. 25,000, while that of Deputy Mayor has been increased from Rs. 13,000 to Rs. 20,000, and of councillors from Rs. 10,500 to Rs. 15,000. The honorarium of President, Municipal Council has been increased from Rs. 10,500 to Rs. 18,000. Now the Vice-President

and Councilors will get an increased honorarium of Rs. 12,000 respectively, in place of Rs. 7,500.

The Chief Minister said the honorarium of president, municipal committee, has been raised from Rs. 6,500 to Rs. 10,000, while that of vice-president from Rs. 4,500 to



hensive infrastructure development involving an investment of Rs 1,400 crore.

BONANZA

Out of the 190 colonies, 100 fall under the jurisdiction of the Town and Country Planning Department and the remaining 90 fall under the purview of the urban local bodies. With these, 594 colonies have been regularized this year.

Highlighting the significant



difference between regularisation of unauthorized colonies during the 10-year Congress tenure and the nine-year tenure of the present government, the Chief Minister said that since 2014, a total of 1,673 colonies had been regularized while only 874 were regularised by the Congress Government.

Stipend paid to Asha workers increased

Asha workers, numbering 20,350 spread over about 7,000 villages, colonies and urban areas across Haryana were the ones the process of showering bonanza began with on October 21.

Making their Diwali brighter, the state government announced an increase of Rs 2,100 in their monthly stipend, taking it to Rs 6,100, besides a retirement benefit of Rs 2 lakh.

A letter has been written to the Union Ministry of Health and Family Welfare to augment the incentive amount for ASHA workers. Notably, in case of an unfortunate incident leading to demise during service, the family of an Asha

According to the Agriculture Department, the area under sugarcane increased to 1.10 lakh hectares in the state from 99,000 hectares last year. The annual yield of sugarcane amounted to about 86,000 kilograms per hectare in fiscal 2021 against 83,000 kilograms per hectare in the country.



etermined to check haphazard growth of industrial units while providing for structured industrial development in the agriculture zones in Haryana, the Manohar Lal Government has come out with a revised policy which supersedes earlier policy instructions issued on July 30, 2021.


The revised policy pertains to permission for change of land use with respect to industrial clusters and individual industrial units contiguous to industrial clusters, including general warehouses, in agriculture zones.

Besides containing haphazard growth of industrial units outside the industrial estates of HSIIDC (Haryana State Industrial Infrastructure Development Corporation) and HSVP (Haryana Shehari Vikas Pradhikaran), it seeks to provide a new framework regarding the grant of CLU in agriculture zones of various development plans.

Need for revised version

The policy seems to appreciate the proclivity of prospective entrepreneurs to set up industrial units in agriculture zones or outside the controlled area due to the exorbitant land cost and high cost of the industrial plots in the industrial estates set up by the HSIIDC or HSVP.

The need for the revised version arose after it came to the notice of the state government that certain parameters of the old policy cried for clarification. These included what constitutes a cluster; detailing the procedure for filing applications by multiple owners, and rationalizing

some parameters. After incisive deliberations, the dispensation has revised and approved various parameters to make the policy more logical.

The following parameters shall henceforth be considered for the grant of permissions: At present CLU permission for industrial units in industrial/agriculture zones is governed by the old policy which

agriculture zones of development plans of towns classified in hyper and high potential zones.

Notably, a large number of people who intend to set up industrial units in Haryana prefer to set up industrial units in agriculture zones or outside the controlled area due to the exorbitant land cost and high cost of industrial plots in the industrial estates developed by the HSIIDC or the HSVP.

Change of land use

This led to a number of scattered industrial units as well as large clusters in agriculture zones without any provision of infrastructure facilities. The revised policy is applicable to change of land use permission in agriculture zones of development plans of various towns for industrial units in industrial clusters and individual industrial units contiguous to an industrial cluster. Industrial units under this policy shall also include general warehouses (other than agriculture produce).

Industrial cluster for the purpose of this policy shall mean ten individual industries in a compact block as defined in Rule 2 (c) of the Haryana Development and Regulation of Urban Areas Rules, 1976, so that cluster members may cooperate for services like, waste management, STP, CETP etc. The minimum number of industries to be allowed in a newly developed cluster (i.e. in case no other adjoining industries are existing) shall be ten in all potential zones.

In case, a group of industries is already in existence before inception of this policy, and, before the declaration of the controlled areas, any fresh application by an individual/firm or group of companies may be considered if a minimum total of industrial units in a cluster (including earlier existing and fresh applied) are ten in number.

However, there shall not be any binding on a minimum number of existing industrial units in this cluster.

In case a deemed cluster of existing industries is to be considered,



then the minimum number of industrial units shall also be 10 in number for Hyper/ High-I & High-II, medium & low potential zones.

The cluster in any of the conditions shall be contiguous for the purpose of connectivity for interlinked services.For the purpose of CLU, permission for an additional unit in addition to the already granted CLU for a cluster of 10 units, no minimum norm for the number of industrial units shall be applicable.

Requirement of CETP

Each industrial unit shall be Zero Liquid Discharge (ZLD), which shall be verified by HSIIDC before grant of the Occupation Certificate. Further, HSIIDC shall convey the land requirement for setting up of CETP and once the cases are examined, the land shall be earmarked at cluster level while grant of CLU permission and same shall be transferred to HSIIDC free of cost. HSIIDC shall get the same developed through Infrastructure Development Fund.

If at any stage, HSIIDC informs in particular case that land earmarked in the layout plan is not required for CETP, the applicant shall be at liberty to obtain relevant permissions on the said chunk of land. Each industrial unit shall be Zero Liquid Discharge (ZLD), which shall be verified by HSIIDC before grant of the Occupation Certificate.

Further, HSIIDC shall convey the land requirement for setting up of CETP and once the cases are examined, the land shall be earmarked at cluster level while grant of CLU permission and same shall be transferred to HSIIDC free of cost. the applicant shall hand over the internal rastas/ roads to the government (gram panchayat/ government agency, as applicable) within 90 days from the grant of CLU permission and no occupation certificate shall be granted within the cluster till the internal rastas/roads are handed over to the government.

The amendments laid out in the revised policy shall be incorporated in the zoning regulations of all development plans immediately.

Henceforth, all cases related to grant of CLU permission for setting up of industrial clusters/units in agriculture zones of hyper, high, medium & low potential zones/ towns be examined in accordance with the aforesaid provisions.

How to be in the queue

The revised policy pertaining to permission for change of land use with respect to industrial clusters and individual industrial units contiguous to industrial clusters, including general warehouses, in agriculture zones, lays down the procedure for filing an application.

It states that one can apply individually or jointly with other land owners as per provision of the Haryana Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act, 1963, giving the following details:

a) Application on CLU-I form for each unit in industrial cluster signed by concerned landowners or any person authorize on behalf of applicant(s) in cluster.

b) CLU application for individual industrial units or for multiple units in the form of cluster can be applied by individual/ firm/ group of companies i.e. even a single individual/ firm can apply for individual unit as well as for multiple units /cluster units.

c) An irrevocable agreement shall be executed between multiple firms/individuals stating that they shall abide by the terms & conditions of the CLU permission and shall also obtain necessary permissions as per the prevailing Act/ rules. The irrevocable agreement shall also mention that all multiple firms/ individuals shall be responsible for development and maintenance of infrastructure services.

d) Scrutiny fee online to DTCP as prescribed in the rule 26-A of Rules, 1965.

e) Revenue documents of the applied area attested by Halka Patwari.

f) A conceptual plan giving details of area, showing the approach road.

g) In case there is violation of Section 7(I) of the Haryana development and Regulation of Urban Areas Act, 1975 then applicant has to apply for composition of violation also.



Three-fold plus hike in exports in 9 years

Exports – which serve as a catalyst for domestic prosperity and global market integration, and promote technological advancement, and enhance the competitiveness of domestic industries –have seen an exponential growth in Haryana in the last nine years under visionary leadership of Chief Minister Mr Manohar Lal.

The state's exports skyrocketed from Rs 68,032 crore in 2014 to Rs 2,45,453 crore in 2022-23. The state has seen a massive investment of Rs 18,422 crore, 1.59 lakh new MSMEs industries and the creation of 12.6 lakh jobs.

Haryana has topped in Export Preparedness Index-2022 among the country's landlocked states of Telangana, Uttar Pradesh, Punjab, Madhya Pradesh, Rajasthan, Jharkhand, Assam, Bihar and Chandigarh.

Haryana has topped the list by scoring 63.65 points, pointing to continued upgradation and improvement in the state's export ecosystem. Prepared by NITI Aayog in association with the Institute for Competitiveness, New Delhi, EPI-2022 has evaluated the performance of the state across four pillars–policy, business ecosystem, export ecosystem, and export performance.

The policy pillar assesses the state's performance based on its adoption of the export-related policy ecosystem as well as the institutional framework surrounding the ecosystem. The business ecosystem has evaluated the prevailing business environment in the state along with the extent of businesssupportive infrastructure, while export ecosystem how the exportrelated infrastructure in the state along with the trade supports has been provided to exporters, and the prevalence of research and development in the state to foster innovation.

In terms of policy, Haryana has logged 99.52 score while Karnataka has topped by scoring 100 points. The state has secured 61.71 score for business ecosystem, 50.65 for export ecosystem, and 49.75 for export performance. Haryana is the best-performing landlocked state and the fifth overall with a score of 63.65 on the index.

Basmati, auto top the list

In the fiscal year 2021-22, Haryana exported merchandise valued over US \$ 15 billion with its top exports being basmati rice and automobile parts. Boasting a robust policy ecosystem, the state has created export promotion policies and institutionalized them with District Export Promotion Committees and District Export Action Plans for all its districts.

On February 14, 2023 Union Home and Cooperation Minister Mr Amit Shah inaugurated the Cooperative Export House, set up by the Haryana government in Karnal to export rice and other agricultural products in a systematic manner and to cooperate with the traders.

He said that with the implementation of the National Cooperative Policy in Haryana and the launch of various cooperative projects, the Cooperative Department will touch new heights.

Central and state governments, nearly 40 lakh Antyodaya families in Haryana can avail the benefits of the Ayushman Bharat-Chirayu Scheme.

Furthermore, this scheme also includes around 38,000 families with an annual income ranging from Rs 1.80 lakh to Rs 3 lakh.

Similarly, the Haryana Income Growth Board aims at increasing the income of Antyodaya families in the state. Under Haryana Antyodaya Parivar Parivahan Yojana (HAPPY), families with an annual income of less than Rs 1 lakh and with three or more members will receive the benefit of free travel on Haryana Roadways buses for up to 1000 kilometres per year. The Mukhyamantri Antyo daya Dugdh Utpadak Cooperative Incentive Scheme will provide incentives to Antyodaya families who wish to start minidairies by taking loans. When these families sell milk in the milk unions, they will receive an additional Rs.10 per litre above the cooperative union's price for one year.

Massive crackdown on stubble burning

44 arrested, Rs 32.55 lakh fine recovered By Ajay Bhardwaj

s the paddy harvesting in the state nears completion , the Haryana government has unleashed a crackdown on stubble burning.

The state government has imposed restrictions on BS-III petrol and BS-IV diesel LMVs (4 Wheelers) in the Gurugram and Faridabad districts with immediate effect until November 30 or until the revocation of GRAP Stage III by the Commission on Air Quality Management, whichever occurs earlier (excluding vehicles deployed in Emergency Services, Police vehicles, and Government vehicles used for Enforcement). Regarding the fixation of hologram-based color stickers on vehicles registered in NCR districts, he said that approximately 10 lakh vehicles have been color-coded in NCR districts between November 14, 2018, and January 31, 2023.


