

# yana ready for Covid vaccination campai

The Haryana Health Depart-ment has conducted a dry run of the COVID-19 vaccine roll out in all the 22 districts in which 3,300 beneficiaries were included and 132 sessions were held.

Secretary, Additional Chief Health, Rajeev Arora said that the dry

run was closely monitored and at one of the sites in rural areas in district Gurugram, World Health Organization (WHO) Country Head (India), Dr. Roderico H Ofrin was present.

Listing out the steps taken by the Department to ensure flawless dry run of the COVID-19 vaccine, Arosaid that various activities like the identification of vaccinators and supervisors, identification of session sites with PIN code tagging, identification of adverse events following immunization (AEFI) management sites and revamping of AEFI Com-mittees, registering vaccination digitally on vaccinator module, session site management were conducted.

He said the dry run was being con-ducted as a part of preparations for successful roll- out of the vaccampaign and to identify any bottlenecks or glitches in operational and technical aspects of implementation.

Earlier, hands-on training on operationalization and use of the CoWIN platform for vaccine and beneficiary management was also given to all district immunization officers with the support of the World Health Organization (WHO) and United National Development Programme (UNDP).

The Haryana Government has declared the area within the radius of one-kilometre from the two poultry farms, whose poultry birds have tested 'Avian Influenza' (H5N8) positive as "Infected Zone" and the area from 1 km to 10 km as "Surveillance Zone".

The state government has restricted the movement of poultry goods from these areas. Adhering to the guidelines, the 1.66.128 birds of five poultry farms which fall within the periphery of 1-km radius of the two infected farms will be culled under the supervision of experts to prevent further spread of the disease and the poultry farm owners will be given compensation for the same.

Animal Husbandry and Dairying Minister J.P. Dalal said that the State Government is concerned towards the poultry business in the staken and clinical investigations were carried out as soon as the State Government was apprised about the unusual death of birds in the poultry farms of Panchkula district. During the investigations conducted by the Department it came to light that around 4 lakh birds have died in these poultry farms in the last one month. birds have died in these poultry farms in the last one month.







# Domestic power connection in 30 days

The Power Department is all geared up to rise to the call and release connections. Besides, the depart-ment has already issued 7,500 tube-well connections and another 3,500 such connections will be released by February, 2021. Disclosing this, the Power Minister, Mr. Ranjit Singh, said

the department had received 17,500 applications for connections. Now, the farmers can purchase 3 Star Motor from the market connections for which will be is-

Not only this! Power supply is set to improve further. For, by March 31, 2021, all dam-aged electric-ity poles will be repaired or replaced. All replaced. Also, the facility of 24-hour Also, the facility of 24-hour power supply is being extended to more villages. Sharing details about successful implementation of the "Mhara Gaon, Jagmag Gaon" Scheme, Mr Singh said that now 24-hour uninterrupted power supply was being given to 5,080 villages of the state.

While 72 per cent of the villages have been covered under the scheme, soon 24-hour

30 per cent to 17 per cent and af-firmative steps had been taken to decrease it further. "I am sure the line losses will be further reduced by 3 to 4 per cent in the near fu-ture", he added. With a view to enhancing

working of the department, 200 SDOs will soon be recruited. Taking steps

to ensure better pow-er supply. Mr Ran-jit Singh said that pilot project regarding installation of smart meters was being conducted in Gurugram, Faridabad, Panchkula and Karnal districts It would be implemented in other cities later. The state government has placed order for 10 lakh smart meters and 20 lakh more meters

will be ordered after the in-stallation of these meters.

### No need to go to court to get fraud deal undone

land deal? Don't worry! You need not knock at the doors of courts to get the deal undone. Approach the registration authority and get the fraudulent deal cancelled.

In what has been billed as a major decision to protect the rights of property owners against any fraudulent transfers, such as sales, the Haryana Government issued a noti-fication on December 23, amending

the Haryana Registration Manual.

Giving details of the amendment, Mr Sanjeev Kaushal, Additional Chief Secretary and Financial Commissioner, Revenue and Disaster Management Department, said, the amendment had been said the amendment had been made to ensure that persons with valid titles would not have to seek legal recourse to get the deed of the fraudulent sale cancelled, and may continue to have the liberty to enjoy their property.

The amendment empowers the

registering officers to accept and register cancellation deeds, can-celling the sale deeds earlier regcelling the sair decus cartier reg-istered fraudulently by a person who is not entitled to transfer such property. If a person has a right in the property and someone else in the property and someone else transfers it without his consent, the right in that property still continues

to subsist in true owner, and the transfer has no effect on such title. According to the amendment, if a document is registered at the instance of a person not duly empowered to present the same, any person claiming under the doc-ument, may, within four months from the date of knowledge that such document is invalid, present such document in such event. The registering officer, after following the same procedure contemplated under the Registration Act, 1908, can re-register the document, that is, cancellation deed, as if it has not been registered previously



# 30 days at max for getting CLU done

Tow, you will not have to make repeated rounds of offices and wait for more than 30 days for wait for more than 30 days for getting permission for change of land use (CLU). With the launch of online service on the New Year Day by the Haryana Town and Country Planning Department, the applicants will get permission within 30 days. In case the department takes longer without raising any objection, the CLU is deemed to be granted. It is a New Year gift for those wanting to get CLU permission for indi-vidual or institutional purposes.

The applicants would be required to visit headquarters of the department for visin headquarters of the department only after signing a bilateral agreement only after the letter of intent is issued. So far, the applicants applying for CLU had to sub-mit documents for physical verification and other purposes which led to inter-face between people and the administra-tion leaving room for interference. tion leaving room for interference.

### Exemption to small traders in market fees

mall traders have a reason to cheer. Giving a major relief to small traders, the to cheer. Giving a major state government has decided to provide one per cent exemp-tion on market fee to such tradhave a turnover of up to Rs 5 lakh per annum.

The Chief Minister has approved a proposal in this regard and to facilitate this, necessary amendments would be made in the Haryana Agricultural Produce Markets (General) Rules, 1962, an official spokesman said. Any small trader who would

submit final annual return in the Market Committee on the closure of financial year showing that his total annual turnover from sale purchase of agricul-tural produce in Haryana is less than Rs 5 lakh in the previous year, would be entitled to claim refund up to 1 per cent on market fees on the said turnover if he has deposited any market fees in any market committee of the

state on such sale purchase. The spokesman said that Mr Manohar Lal had also approved to amend Rule 17 of the Haryana Agricultural Produce Markets (General) Rules, 1962 providing for the criteria for issue of category (iii) licence. According to the amendment, the requirement for getting this category (iii) license would be exceeding Rs 5 lakh and not exceeding Rs 12 lakh. With this, the small traders

with annual turnover of less than Rs 5 lakh would not have to get the license required under section 10 and Rule-17. Besides, they would not have to maintain and submit the required record to the concerned market committee and no market fee would also be leviable from such small traders

## Forest cover in Haryana up 14.44 sq km

The concerted and continuous plantation and conservation efforts made by the Hary-ana Government, led by the Chief Minister, Mr Manohar Lal, have borne fruit. According to the In-State of Forest Report (ISFR) 2019, the forest cover in the state has increased by 14.44 sq km as compared to the previous assessment reported in ISFR 2017. The ISFR report has been released by the Union Ministry for Environ-ment, Forests and Climate Change.

Based on interpretation of the satellite data for the period October to December 2017, the forest cover in the state aggregates 1,602.44 sq km which works out to 3.62 per cent of the state's geographical area. In terms of the forest canopy den-sity classes, Haryana has 28 sq km under Very Dense Forest (VDF), 450.90 sq km under Moderately

sq km under Open Forest (OF). The Recorded Forest Area (RFA) in the state is 1,559 sq km of which 249 sq km is Reserved Forests, 1,158 sq km is Protected Forests and 152 sq km is Unclassed Forests. The RFA amounts to 3.53% of its geographical area.

The reserved, protected and unclassed forests are 15.97%. and 9.75% of the recorded forest area in the state, respectively.

The state government has placed special emphasis on soil and moisture conservation works in the hills to conserve water and deliver it to the adjacent farmlands for increasing their productivity and enhanc-ing incomes. Besides, herbal parks have been developed in every district to bring people closer to the natural ecosystem.

The report points out that be-tween January 1, 2015 and Febru-ary 5, 2019, a total of 1,529 hectares of forest land was diverted for non-forestry purposes under the Forest Conservation Act, 1980. Two national parks, eight wildlife sanctuaries and two conservation reserves constitute the protected area network of the state, covering 0.75% of its geographical area.

Haryana is primarily an agri-cultural state and 80% of the total geographical area is under agricul-ture. According to the Champion & Seth Classification of Forest Types

#### ISFR and role defined

- ISFR is a biennial publication of Forest Survey of India (FSI), an organization under the Ministry of Environment Forest & Climate Change.
- It assesses forest and tree cover, bamboo resources, carbon
- stock and forest fires. The 2019 report has for the first time assessed the qualitative nature of the forest cover, including listing its biodiversity and the type of plants and trees found. It also created a national forest inventory for the first time
- on produce from forests.

(1968), the forests in Haryana belong to three Forest Type Groups i.e. Tropical Dry Deciduous Forest, Tropical Thorn Forest and Subtropical Pine Forests which are

divided into 10 Forest Types. Looking at the performance of districts, the report says that while Mahendragarh and Rewari recorded an increase in the forest area of 4.29 per cent and 3.45 per cent respectively, it shrunk by 0.03 per cent in Palwal. (See Chart)

Haryana is geared to provide tap water connection to all rural households by December, 2022. The state provided 1.05 lakh tap connections during 2019-20 under the Jal Jeevan Mission (JJM). Now the State Government is planning 100 per cent coverage by December, 2022, ahead of the national goal by 2024-25.

By doing so, Haryana will be among the leading states to accomplish the ambitious target of providing tap connection to each rural household. There are 28.94 lakh households, out of which 18.83 lakh have already been provided with the Functional Household Tap Connection (FHTCs). Out of the remaining 10.11 lakh households, Haryana plans to provide tap connections in seven lakh households by 2020-21.

More emphasis has been laid on covering rural households in drought prone areas and aspirational districts.
