# Haryana offers big relief to NCR farmers

In a major relief to farmers in the National Capital Region (NCR) the Haryana Assembly unanimously passed the Haryana Laws (Special Provisions) Amendment Bill, 2022, to exempt tractors for three years tractors from a rule that bans diesel vehicles older than 10 years in the NCR.

This has been done in the line of assurance given to the House by Chief Minister Mr Manohar Lal that the state government would fervently protect the interests of farmers. He promised that the state government within the validity of this Act shall make a policy for phasing out the specified agricultural purpose vehicles from the NCR.

The bill tabled in the House by Transport Minister Mr Mool Chand Sharma seeks to amend the Haryana Laws (Special Provisions) Act, 2019.

According to the government, in pursuance of various orders passed by the National Green Tribunal and the Supreme Court from time to time, there is a complete ban on the operation of diesel vehicles older than 10 years in the NCR. Accordingly, the operation of such vehicles, including specified agriculture purpose vehicles, is not

allowed in the districts of Haryana falling in NCR.

In order to provide temporary relief to the farmers and other affected people residing in the districts of Haryana falling under NCR in respect of the operation of specified agriculture propose vehicles, the Haryana Laws (Special Provisions) Act, 2019 was got notified by the state government on March 18, 2019, having validity of one year from the date of its commencement," read the provisions of the Bill.

The minister said the validity of the Act will be enhanced up to June 30, 2025. "And in this period of time, various policy issues and support for phasing out the specified agriculture vehicles from the National Capital Region are expected to be finalised," Sharma added.

According to the provisions of the Bill, "all notices issued by the state government or any authority for any coercive action against any specified agricultural purpose vehicle only on the ground that such specified agricultural purpose vehicle has been registered for a period of ten years or more, shall be suspended and no coercive action shall be taken from the date of commencement of this Act till June 30,2025"

# It's Farz ka Budget, not of Karz

CM swears by Antyodaya, reiterates commitment to reach out to last man standing


edicated to Antyodaya, the 2022-23 Budget 'is more of a 'Farz' ka Budget than of Karz.' Every eligible beneficiary would certainly get due benefits. Since the poor person has the first right on the government, every possible effort would be made to ensure that benefits of the plethora of state welfare schemes reach the poorest of the poor first.

In stating this while relying on the debate on the Budget in the state Assembly on March 21, 2022, the Chief Minister, Mr Manohar Lal, killed two birds with one stone. He reiterated the commitment of his government to reach out to the last man in the queue, and also refuted the criticism from across the political aisle that the burden of debt was mounting on the state.

The Chief Minister said in the last two years, due to COVID-19, the pace of development had slowed down, but every possible effort is now being made by the government to constantly maintain this development pace.

"A new initiative of holding a pre-budget meeting was started by our government under which valuable suggestions were sought from all the stakeholders before finalizing the Budget. This time also consultation meetings were held with about 550 people and their valuable suggestions have been included in the Budget," said the Chief Minister.

The committees constituted to



discuss the budget demands have also shared their suggestions, most of which have been incorporated by the state government.

Committee-1 has suggested that a mechanism should be put in place for monitoring the Budget estimates, which has been accepted by the government and an online mechanism will be developed by the Finance Department for the same. Similarly, Committee-2 has also recommended that an orientation programme should be started for the MLAs. Necessary arrangements will also be made for the same," shared Mr Manohar Lal.

Responding to the questions raised by the Opposition regarding the loan figures, Mr Manohar Lal said the Opposition leaders should change their viewpoint whenever they talk about debt, as the debt increases over time, but economists and NITI Aayog assess the economic conditions healthy going by the debit-to-GSDP ratio.

According to this calculation, the debt should not exceed 25 per cent of GSDP. Despite the COVID-19 Pandemic, the state's ratio is 24.98 per cent whereas in Punjab it is 48 per cent, the Chief Minister said. The revenue deficit of Haryana is also less than 3 per cent.

"If we are doing capital expenditure by taking loans and promoting infrastructure, then it is a good thing because infrastructure is considered an investment with a perspective of a bright future. In this Budget, we have made a provision of capital expenditure of Rs 61,057.36 crore," Mr Manohar Lal added.

# None involved in graft 'will be spared'

he Chief Minister said that he would not spare anyone found guilty of corruption. Stringent action will be taken against all such violators, whether it is an IAS officer or anyone else.

He was answering a query from the media regarding naming of IAS officers involved in a corruption case of Faridabad Municipal Corporation at a press conference held at the conclusion of the Budget session of the state Assembly. In all, nine cases have been registered in the case which are being investigated by the police or Vigilance.

The Chief Minister said that earlier only colonies built in cities up to 50 per cent were authorized. But now this condition has been removed and colonies built up to 10 to 20 per cent will also be authorized. If such a colony is lying vacant, its development charge will have to be paid to the builder.

Where houses are built, they will have to pay a charge of 5 per cent of the collector rate. Registries done wrongly without NOC under the guise of 7-A between the years 2017 to 2021 have been investigated by the government. "I have announced in

the House that such registries, which took place between 2010 and 2016, will also be investigated", he added.

Responding to a question related to the Chintel Society of Gurugram, he said that structural audit of buildings would be mandatory so that such incidents did not happen in future. The license to Chintel Society was given by the Congress Government in 2007. Many more towers have been built by the same builder.

The investigation of this case has been handed over to the CBI. Case study will also be conducted in case of buildings constructed without occupation certificate.

On the Prevention of Unlawful Conversion of Religion Bill, 2022, the Chief Minister said vested interests of Congress for the minority seems to have been exposed. A person can change religion as per own wish, but the conversion will not be allowed under any influence.

Strict action will be taken if religious conversion is done under coercion or allurement. Although action is being taken against the accused under the IPC, but in view of the seriousness of the matter, a separate Act has been brought. Before Haryana, many other states have also passed a similar Act.

# Pulling all stops to sav Overarching policy bets big on use of treated waste water

If there is water, there is life. Water, rightly called the elixir of life by Dr C V Raman, is the most important natural resource on the earth to sustain all forms of life. Given its paramount importance and the hard and harsh reality that it is a limited resource, water needs to be used judiciously.

This hypothesis gets doubly underscored in the context of Haryana where about 60 per cent of the groundwater is brackish and unfit for human consumption. Conscious of the grave reality and great need to address the issues of limited availability of water resources and the quality of water, the Manohar Lal Government has come out with an overarching policy on water conservation with emphasis on reuse of the treated water.

The message woven into the fabric of the policy is loud and clear: mere conservation efforts won't do, we need to treat used water and recycle it for use again at least for non-potable purposes. It aims at maximizing collection of sewage and its treatment, and increasing reuse of the treated water for non-potable applications to reduce dependency on the limited ground and surface water resources.

"Water is a precious resource and the Haryana Government is committed to its conservation, and preservation demand management for future generations of Haryanvis. Guided by the vision of the Prime Minister, Mr Narendra Modi, we are making best possible efforts to optimise utilisation of water resources, promote use of treated water, set up rain water harvesting structures and adopt ground water recharging techniques", the Chief Minister, Mr Manohar Lal, said.


Water conservation, combined with measures to tap more resources to boost supply by setting up check dams and recharge bore wells, and promoting the use of recycled waste water constitute the bedrock of the strategy. Good progress has been made on all these fronts.

The Central Government had launched "Jal Shakti Abhiyan: Catch the Rain" campaign to cover all districts in rural as well as urban areas of the country.

Focused interventions under the campaign included intensive

With a view to lending financial muscles to this composite effort, a sum of Rs 4,554.39 crore has been allocated to the Public Health Engineering Department in the Budget for FY 2022-23, 33.9 % more than the estimates for the current year.

Countless numbers of Central and state government schemes have been implemented in Haryana to translate the vision of the Prime Minister on water conservation into reality.

### **Jal Jiwan Mission**

Haryana has successfully implemented the Jal Jiwan Mission of the Central Government and completed the work of providing piped water supply to households in 19 districts. Work in the remaining three districts – Jind, Palwal and Nuh– will be completed very shortly. With this the promise of providing piped water supply to every eligible household two years before the projected timeline of 2024, will be kept.

The state government started the Mahagram Yojana for augmentation of the drinking water supply, laying of sewerage systems and installation of sewage treatment plants. Under this programme, 132 villages have been identified.

# Water Resources Authority

With a view to addressing the problems of water depletion and water-logging in parts of the state, the government has set up Haryana Water Resources (Conservation, Regulation and Management) Authority which has categorised villages on the basis of the water level. As many as 1,948 villages have been classified as severely stressed groundwater villages. On the other extreme, 85 villages have been classified as severely water-logged villages.

The Authority is preparing a District Water Resources Plan based on the ground water level data. This will help in the preparation and implementation of 'Dwivarshik Jal Prabandhan Yojana' announced in the Budget last year. These district-level plans will be integrated into a

comprehensive state level water plan to ensure optimal use of groundwater and surface water resources.

### Pond Authority set up

Ponds are the traditional source of water in the villages. In order to improve and rejuvenate them, the state government has set up Haryana Talab and Waste Water Management Authority. The Authority has uploaded the data of all the 18,281 ponds on the data management system. Work has been completed on the improvement and restoration of 905 ponds

There are many ponds in which only dirty water keeps accumulating. A three-pond scheme has been started for them. Under this scheme, the water is purified so that it can be used for irrigation.

Under Jal Shakti Abhiyan, the grant limit on the construction of individual water storage ponds for irrigation of horticultural crops through micro irrigation system has been increased from Rs.75,000 to Rs 7 lakh for ground water recharge.

Boiling things down to essentials, conservation runs parallel to the efforts being made by the Manohar Lal Government to increase water supply both for drinking and irrigation purposes. Water Biennial 2021-2023' is being celebrated in the state to focus on conservation, management, reuse, recharge and recycling of water.

The Water Authority is working hard to put in place a sustainable water resources regime to facilitate a holistic view of the ground and surface water to promote its judicious, equitable and efficient use.

ater conservation will lose meaning if we do not prepare ourselves to treat and use waste water. Policy changes have been made to encourage its use by power plants, industries, irrigation and municipalities for non-drinking purposes to ensure that fresh water resources are conserved.

Sewerage treatment plants and common effluent treatment plants have been set up to generate 1,967

MLD of treated waste water. The recommendations of the Haryana Water Resources Authority on the tariff for use of treated wastewater and the sectors where its use can be mandated are expected shortly.

# Check dams being set up

Inspired by the Prime Minister's remark that "when clouds rain, they rain not only for us but also for the generations to come", the Manohar lal Government has taken several initiatives to harness the rain water.

The Shivalik Hills in the

northern part and Aravalli Hills in southern Haryana constitute major watersheds. A number of water springs and small creeks exist in these hills which carry water during monsoon. To conserve and utilise water run-off, check dams have been planned in Shivalik Hills and Aravalli Hills.

Continuous efforts are being made for the construction of upstream storage dams on Renuka, Kishau and Lakhwar Vyasi tributaries of river Yamuna for improving water supply. The Prime Minister laid the foundation stone

# Water bodies mapped; Jal Shakti Kendras set up in all districts

aryana has adopted a holistic approach to solving all water related issues. Jal Shakti Kendras which function 24X7 as one-stop knowledge center for all water related information and water related activities, have been set up in all districts of the state.

Proceeding scientifically, Haryana is the only state to have mapped and geo-tagged all water bodies. A total of 37,353 water bodies (23,894 natural and 12,957 man-made) were identified on imagery followed by a village-wise survey. Demarcation using Google-Earth was also done on images, and a total 28,505 water bodies were found.

A total of 16,348.66 km canal/drain network of the state was mapped involving total coverage of 64,044.53 acres. A total of 5,066 structures for rooftop rain harvesting were identified and listed using mobile-based application.

District Water Conservation Plans for each district have been prepared and uploaded on Jal Shakti Abhiyan Central Portal. These incorporate general information on the district, its water profile, water availability, water requirement/demand and strategic action plan for conservation, public education and awareness, and department-wise action plan/strategy.

Haryana is also the only state to have accomplished the task of preparing village-level contour maps of all districts which have been incorporated in the district water conservation plans. Krishnawati and Dohan rivers have been rejuvenated. Haryana has implemented six major targeted interventions under Jal Shakti Abhiyaan-II besides intensive IEC activities in all districts.

Evidences of positive impact of water management activities are published in high impact factor journals, including the Arabian Journal of Geosciences, Journal of Agro meteorology among others.

### Mera Pani, Meri Virasat

Water conservation strategy spans both rural and urban areas. While farmers are being incentivized to grow other than water-guzzling paddy, saving rain water and reuse of treated water is being emphasized in the urban areas through a number of schemes.

One such landmark scheme is Mera Pani Meri Virasat. Under this initiative implemented in

Mission Mode in Haryana, farmers are incentivized to switch from paddy to other crops.

"A lot of brainstorming was done with farmers, scientists, MLAs and other people associated with the government before formulating the Mera Pani, Meri Virasat scheme, which will be very beneficial for the coming generations in conserving water," says the Chief Minister.

Such farmers as grow crops other than paddy on at least 50 per cent of their paddy area last year by growing alternative crops such as maize, cotton, bajra and pulses, are provided Rs 7,000 per acre as incentive. They are not permitted to cultivate paddy in any new areas where paddy was not grown during last year. Farmers operating tube wells with 50HP electric motors are not allowed to grow paddy.

In order to further incentivise the farmers, the Manohar Lal Government has decided that all diversified crops such as maize, bajra and pulses will be procured at the MSP. Not only this, the government has also promised to provide 85 per cent subsidy for the installation of drip irrigation system in the alternate diversified crops.

**Promoting micro irrigation** 

Micro irrigation is being

promoted. The government bears 85 per cent of the expenditure on auxiliary infrastructure while farmers have to pay only 15 per cent of the cost. This year, ₹ 1,214 crore has been proposed as subsidy under Per Drop More Crop component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY).

While steps are being taken to enable the farmers conserve water, avenues are being explored to make more water available for irrigation. For enhancing capacity of the canal network, construction of new Parallel Lined Channel and remodelling of the Western Yamuna Canal, Augmentation Canal, Parallel Delhi Branch, Hansi Branch, Jawaharlal Nehru Canal have been started.

The state government also plans to improve capacity and efficiency of pumping machinery of the lift irrigation system in Rewari, Mahendergarh, Charkhi Dadri and Bhiwani districts.

In order to meet the drinking water needs for Nuh and Gurugram districts, the government has decided to construct Mewat Feeder Canal of 200 cusecs capacity and also undertake remodelling of Gurgaon Water Supply (GWS) Channel with capacity of 475 cusecs from the existing capacity of 175 cusecs.

of the Renuka Dam in December last year. The total storage capacity of these check dams will be about 37.36 million cubic metres (MCM).

With a view to recharging the ground water with rain water, 1,000 recharging bore wells and shafts are being constructed at a cost of Rs.39.66 crore. Target has been set to construct 5,000 recharge bore wells in 2022-23.

Simultaneously, the government has successfully implemented Atal Bhujal Yojana to promote community-led sustainable ground water

management in 1669 Gram Panchayats of 14 districts identified as water-stressed areas. It has been decided to utilize the monsoon water for irrigation. This will benefit farmers in two ways: prevent inundation of the crops and help in irrigating fields when water is required.

For revival of the Saraswati River, an MOU for the construction of Rs 388-crore Adi Badri Dam with storage capacity of 224 hectare meters has been signed with the Government of Himachal Pradesh.

# CM warns pseudo-social NGOs against fraudulent conversions

aryana Chief Minister, Sh. Manohar Lal said that The Haryana Prevention of Unlawful Conversion of Religion Bill, 2022, passed by the Vidhan Sabha during the budget session, was aimed at instilling fear among those who resort to fraudulent means for conversions in religion.

The Chief Minister said that the bill in no way stops a person from undertaking a willful conversion but no coercion or deceit would be allowed in such cases. The purpose of this Bill is to control forced religious conversions in the state.

While underlining that many other states have also passed similar bills the Chief Minister said that 127 FIRs had been registered in six districts in the last four years on charges of deceitful conversions. Many more cases of conversion have come to light places like Yamunanagar, Panipat, Gurugram, Palwal, Faridabad.

He said some pseudo-social organizations with a hidden agenda target the vulnerable sections of the society forconversions.

There have also been cases where people marry girls of other religion by misinterpreting their own religion and after marriage, such girls were forced to convert their religion. Such incidents not only violate the religious freedom of individuals but also harm the socio-religious fabric of our society. To prevent these incidents, The Haryana Prevention of Unlawful Conversion of Religion Bill, 2022 has been passed.

The new law prohibits unlawful conversion from one religion to another by misinterpretation, use of force, threat, undue influence, coercion, allurement or by any fraudulent means or by marriage.

It says that if a person wants to convert voluntarily, he will have to submit a declaration of conversion in the prescribed format to the District Magistrate.

# Regulating human organ transplantation

The Vidhan Sabha also passed the Transplantation of Human Organs (Haryana Validation) Bill, 2022, to ensure that for the removal, storage or transplantation of human organs or tissues or both of the donor, the hospital will have to inform the Human Organ Removal Centre in writing.

The chief minister said that there is no human organ transplant facility in Haryana so far. But now kidney transplant facility will start in PGIMS Rohtak after the passing of The Transplantation of Human Organs (Haryana Validation) Bill.

The bill says there must be a sufficient warrant for the human organ to be removed for medical purposes only by a registered



medical practitioner. Where the donor or the recipient being near relative is a Foreign National, it shall be necessary to obtain prior approval of the Authorisation Committee before the removal or transplantation of human organ or tissue or both.

If the recipient is a foreign national and the donor is an Indian national, the Authorisation Committee will not approve such removal or transplantation unless they are near relatives. Similarly, no human organ or tissue or both shall be removed from the body of a minor (child) before his death, except as prescribed for the purpose of

transplantation. No human organ or tissue or both shall be removed for transplantation from the body of a mentally challenged person before hisdeath.

### **Public Utilities Bill**

The Vidhan Sabha also passed The Haryana Prohibition of Change of Public Utilities Bill, 2022.

The Chief Minister said that 50 years ago people used to donate or gift their land to the government for developmental schemes. These donations and gifts were given with verbal consent, nothing was given in writing, he added.

"Today their generations go to court and claim that the donated or gifted land belongs to them and publicutility properties built on these lands should be dismantled. Therefore giving relief from such litigations, The Haryana Prohibition of Change of Public Utilities Bill, 2022 has been brought," added Sh. Manohar Lal.

### Kisan Kalyan Pradhikaran bill

The Vidhan Sabha also passed the Haryana Kisan Kalyan Pradhikaran (Amendment) Bill, 2022 under which now Chief Executive Officer, Additional Chief Executive Officer and Joint Chief Executive Officer can be appointed in the Haryana Kisan

# Rs 193 crore for Haryana as ULB grant

he Central government has released Rs 193.50 crore as grants to the Urban Local Bodies (ULBs) of Haryana. The grants are meant for sanitation, solid waste management and attainment of star ratings as developed by the Union Ministry of Housing & Urban Affairs (MoH&UA), and drinking water, rainwater harvesting and water recycling. In the current financial year, the Government of India has released a total amount of Rs 10,699.33 crore so far to the States as grants to the non-million plus cities (NMPCs). These grants are released by the Union Ministry of Finance on the recommendations of MoH&UA.

According to the Union Finance Ministry, the 15th Finance Commission in its report for the period from 2021-22 to 2025-26 has divided the ULBs into two categories: Million-plus urban agglomerations or cities excluding Delhi and Srinagar, and all other cities and towns with less than one million populations. The 15th Finance Commission has



recommended separate grants for them.

Out of the total grants recommended by the 15th Finance Commission for NMPCs, 40 per cent is basic (untied) grant and the remaining 60 per cent is tied grant. Basic grants (untied) are utilised for location specific felt needs, except for payment of salary and incurring other establishment expenditure. On the other hand, tied grants for the NMPCs are released for supporting and strengthening the delivery of basic services.

Out of the total tied grant, 50 per

cent is earmarked for 'sanitation solid waste management and attainment of star ratings as developed by the MoH&UA. The remaining 50 per cent is tied to 'drinking water, rainwater harvesting and water recycling.'

The tied grants are meant to ensure availability of additional funds to urban local bodies over and above the funds allocated by the Centre and the state for sanitation and drinking water under various centrally sponsored schemes and provide quality services to citizens.

Since ULBs are important

institutions of self governance, providing physical infrastructure and civic amenities in urban areas, the state government has taken a number of initiatives to make them more effective and resilient. As per the Census 2011, more than 35 per cent of the state's population lives in urban areas. There are 93 ULBs in the state comprising 11 Municipal Corporations, 22 Municipal Councils and 60 Municipal Committees.

In 2021-22, a new scheme called Mukhyamantri Samagra Shahari Vikas Yojana was launched in order to provide basic civic amenities in financially weak municipalities. Geographical Information System (GIS) based property survey work in all ULBs is under progress. Deen Dayal Antyodaya Yojana – National Urban Livelihood Mission addresses livelihood concerns of the urban street vendors by facilitating access to suitable spaces, institutional credit, social security and skills to them for accessing emerging market opportunities. The Mission aims at providing shelters equipped with essential services to the urban homeless in a phased manner.

# Haryana tops in CM gets COVID-19 Commitment Award water conservation

aryana has achieved the first position in the country in water conservation and has been conferred the Water Conservation Award.

Chief Minister Mr Manohar Lal said the state government is not going to end up with this achievement. Better steps will be taken for water conservation in future.

The Chief Minister said that the Haryana Water Resources (Conservation, Regulation and Management) Authority (Amendment) Bill, 2022 has also been passed, which aims to regulate the use of treated wastewater in the state. At present, there are many decisions and rules regarding the reuse of this water. Therefore, it was felt that a single mechanism should be made for this. In addition, the Haryana Water Resources (Conservation, Regulation and Management) Authority will also recommend tariffs for all uses of treated wastewater.

The bill was passed to further the Haryana Water Resources (Conservation, Regulation and Management) Authority Act, 2020 for conservation, regulation and management of water resources in the State, including water reuse and recycling.

The purpose of this amendment is to regulate the use of treated wastewater in the state. At present, there are a number of decisions and conditions regarding the reuse of Treated Waste Water. Therefore, the need for a single regulatory mechanism was identified.

Further, the need to fix tariff for all types of water uses was also identified. Thus, the Act is being amended. The Authority shall decide tariff on the basis of consumption for excessive use of available surface water and treated wastewater. The Authority shall also recommend to the Government the retail rates of water for households, industries commercial establishments.

The Haryana Water Resources Authority has categorized all the villages of the State in seven different categories based on the groundwater table. The Authority has categorised 1948 villages as severely groundwater stressed villages where depth to water table range is between 30.01 and more, 1093 villages are categorised as moderately groundwater stressed villages where the depth of water table's range is between 20.01 to 30.0. Meanwhile, 333 villages are potential categorized as waterlogged villages where the depth to the water table is 1.51 to 3.0 and 88 villages are categorized as severely waterlogged villages where the depth to the water table is 0.0 to 1.5 meters.

A 10-year study on the groundwater depletion pattern in different areas of Haryana suggested that the groundwater table of the state is depleting in a

range of 0.03- 1.12 meter per year. Wells of most of the districts of Haryana have dried up. The water level fell over 30 meters in 1780 villages. This alarming depletion of the groundwater table indicates the huge water crisis in the future. To cope with this issue, an initiative was taken by the Haryana Government on 6 May 2020.

Called the "Mera Pani Meri Virasat" scheme, it grants assistance to farmers to the tune of Rs 7,000 per acre of land to quit paddy cultivation and shift to pulses or low water demanding crops. # New hockey astro turf for Nehru Stadium
