## Sankalp Yatra turns into a mass movement

### Haryana logs 3rd highest growth in collections

### Revenue mop-up up 44 pc in Nov

here are no two opinions that higher tax collection has a profound impact on both development and people's lives. Haryana, under the visionary leadership of the Chief Minister, Mr Manohar Lal, logged an impressive 44 per cent increase in GST collection in November, 2023, the highest among the big states, and third in the country. The first and second are Nagaland (99 pc) and Arunachal Pradesh (48 pc).

According to the Union Ministry of Finance, Haryana collected Rs 9,732 crore as GST revenue in November as compared to Rs 6,769 crore mobilized in November 2022. The credit goes as much to the economic growth of the state as much to the anti-evasion measures taken by the state government.

The buoyancy in tax figures assumes significance as increased government revenue through taxes enables the financing of essential public services such as education, healthcare, and infrastructure, lay-



ing the foundation for sustainable development. Adequate funding for education, for instance, can enhance the quality of schools and promote literacy, ultimately equipping citizens with the skills needed for a competitive workforce.

#### Better than neighbours

Haryana's tax collection is better than that of the neighbouring states. The GST mop up in November 2023 in Punjab stood at Rs 2,265 crore, Himachal Pradesh Rs 802 crore, Chandigarh Rs 210 crore, Uttarakhand Rs 1,601 crore, Delhi Rs 5,347 crore, Rajasthan Rs 4,682 crore, Uttar Pradesh Rs 8,973 crore, and Jammu and Kashmir Rs 469 crore. The gross GST revenue collected at the national level in November, 23 has been pegged at Rs 1,67,929 crore.

The surge in GST collections not only mirrors the state's economic advancement, but is also a positive sign for overall development. It reaffirms the effectiveness of the GST system, which was implemented nationwide with the concept of 'One Nation, One Tax'.

It is worth mentioning that Haryana was among the top five states in the country to collect the maximum amount of GST revenue in the first six months of the current fiscal year, which underscores the state's steady economic growth and financial stability. In the first six months of the current financial year

(April-September), Haryana's total tax collection was Rs 32,076 crore as compared to Rs 27,155 crore during the corresponding period in the previous year.

#### **Surge in collections**

The surge in GST collections not only mirrors the state's economic advancement, but is also a positive sign for overall development. It reaffirms the effectiveness of the GST system, which was implemented nationwide with the concept of 'One Nation, One Tax'.

The simplification of the GST process has not only benefited entrepreneurs but has also strengthened government revenues, as per the statement. The state government is modernising and strengthening the infrastructure of the Excise and Taxation Department.

The adoption of digitalization in tax collection processes is a notable step forward. The department is focused on minimizing revenue leakages while maximizing collections.

In addition, the department is committed to meeting its revenue collection target of Rs 57,931 crore, as set in the state budget.

### Policy tweaked to lend connectivity thrust

n a significant move aimed at enhancing the availability of highquality technology and communication infrastructure to foster connectivity throughout the state, the Haryana Cabinet, chaired by Chief Minister Mr Manohar Lal here on November 27, 2023, approved the revision of the Communication and Connectivity Infrastructure Policy-2023. The updated policy supersedes the Communication and Connectivity Policy-2017 and aligns with the amended Indian Telegraph Right of Way Rules, as notified by the Union Ministry of Communication (Department of Telecommunications) in 2022.

The decision assumes significance as communication and connectivity infrastructure serves as the back bone of our interconnected world, enabling seamless interaction and information exchange across the globe. Comprising a network of physical and virtual components, this infrastructure encompasses a wide array of technologies, including telecommunications net works, internet backbones, and satellite systems.

#### **Connectivity infrastructure**

The visionary leadership of Chief Minister Mr Manohar Lal is ensuring the robustness and efficiency of communication and connectivity infrastructure, which is crucial for fostering economic growth, innovation, and social development. In the digital age, communication infrastructure not only facilitates the rapid transmission of data but also supports the proliferation of emerging technologies such as 5G, the Internet of Things (IoT), and artificial intelligence.

The decision of the Cabinet encourages the integration of cuttingedge technological advancements in the telecom sector, including Fibre to the Home (FTTH), and innovative business models like the Open Access Network (OAN), which separates physical access to the network from service delivery.

The revised policy establishes a framework for the creation of enabling 5G infrastructure including through ducts alongside roads, al-

### One-time scheme for settlement of dues

n a proactive measure aimed at expediting the recovery of outstanding dues and reduce the litigations, the Haryana Cabinet, which met under the chairmanship of Chief Minister Mr Manohar Lal here on November 27 approved a unique one-time settlement scheme titled 'The Haryana One Time Settlement Scheme for Recovery of Outstanding Dues 2023' with a view to move ahead in the GST regime with lesser baggage of arrears and litigations.

It may be mentioned here that the Chief Minister in his Budget Speech had said that such a settlement scheme for recovery of arrears would be introduced under the 'Vivadon Ka Samadhan' Scheme.

The new scheme is designed to facilitate the recovery of outstanding dues governed by various Acts of the Excise and Taxation Department in the pre-GST

The scheme will be effective from the date of its notification.

Applicable Acts covered under this scheme include the outstanding arrears relating to the seven Acts, namely, Haryana Value Added Tax Act 2003, the Central Sales Tax Act 1956, the Haryana Local Area Development Tax Act 2000, the Haryana Tax on Entry of Goods into Local Areas Act 2008, the Haryana Tax on Luxuries Act 2007, the Punjab Entertainment Duty Act 1955, and the Haryana General Sales Tax Act 1973.

lowing multiple service providers to share the same infrastructure to optimize Right of Way (RoW) availability and prevent frequent disruptions caused by multiple infrastructure providers digging in the RoW.

Under the newly approved schedule, if the nodal officer fails to either grant permission or reject the application within 45 days from the submission date, permission will be deemed granted. The Deputy Commissioner of the concerned district will be the single contact person for all clearances.

#### 7 more castes in SC list

The Cabinet also accorded approval to a proposal regarding the deletion of names of seven castes, namely, Aheria, Aheri, Heri, Hari, Turi or Thori from Serial No.1, amendment of the word Jangam-Jogi as Jangam at Serial No. 31 and omission of Rai Sikh caste from Serial No. 50 in the state list of Backward Classes (Block-A). With this decision, these castes will be eligible to take benefit under the Scheduled Castes category.

Chief Minister Mr Manohar Lal said that the Haryana Scheduled Castes Commission will send a written communication to the Central Government for the inclusion of 'Naik' community of the state into the list of Scheduled Castes category. As per the directives of the Government of India, further action in this regard will be taken.

# 22,000 stage III and IV cancer patients to get assistance

n a bid to alleviate the finan- tling cancer but also the significant fihelp, the Haryana Cabinet which met under the chairmanship of Chief Minister Mr Manohar Lal here on November 27, 2023 approved a scheme for giving financial assistance for Stage III and IV cancer patients. With this decision, around 22,808 patients will get the benefit.

This landmark decision is of paramount significance as cancer treatment, with its associated medical expenses, places an overwhelming strain on individuals and their families, jeopardizing their financial stability. Extending financial help to critical cancer will address not only the formidable physical challenges of bat-

cial burden faced by eligible nancial burden that often accompa-Leancer patients by providing them with monthly financial nies the disease. The monthly financial shall be a citizen of India and a resident of Haryana and should under this scheme will be in addition to the benefit being availed under any other social security pension scheme by the applicant.

#### Rs 2750 per month

The financial assistance to eligible patients shall be given at equal to old Age Samman Allowance. Initially, from now onwards, the patients will receive monthly assistance of Rs 2750, while from January 2024 the amount will be Rs 3000. It is worth noting that during the inauguration of the Atal Cancer Care Centre (ACCC), Ambala Cantonment, Chief Minister Mr Manohar Lal had announced a pension for cancer patients of Stage III and IV.

A person eligible for financial assistance under the scheme be residing in the state for the last 15 years on the date of submission of the application, and should have Parivar Pehchan Patra (PPP). All age group Stage III and IV patients will be eligible under the scheme and patients whose family income is less than Rs 3 lakh per annum, except the amount of other Social Security Pension Schemes will be eligible.

This scheme shall come into operation from the date of its publication in the official gazette. The assistance amount would be directly transferred into the bank accounts of the beneficiaries through PFMS.

#### Panchayats to sell land

The Cabinet has also approved the proposal of Development and Panchayats Department regarding the sale of land measuring 350.5 acres of Panchayati land of three villages Asan Kalan, Khandra and Bal Jattan to Indian Oil Corporation Limited Panipat Refinery and Petrochemical Complex for the first phase expansion of IOCL Panipat Refinery.

IOCL will purchase land measuring 140 acre 6 kanal 12 Marla of Asan Kalan village, 152 acre 2 kanal 15 Marla of Bal Jattan village and 57 acre 2 kanal 19 marla of Khandra village at the rate of Rs 2.2 crore per acre.

In addition, IOCL shall also pay Rs 10 lakh per acre to the Gram Panchayats for development works in the respective village.

### Giving infra a shot, overall growth a leg-up

Infrastructure plays a critical role in the socio-economic development of the state, serving as the backbone that supports various facets of daily life and fosters overall growth. It encompasses a wide array of essential systems and facilities including transportation networks, energy grids, water supply, communication systems, and public services.

Under the visionary guidance of Chief Minister Mr Manohar Lal, Haryana government is leaving nothing unturned to facilitate commerce, enhance connectivity, and improve the quality of life for citizens. Efficient transportation infrastructure, for instance, not only accelerates the movement of goods and people but also contributes to economic productivity.

Today Haryana boasts of having one of the best road networks in the country. However, the pace of investing in and maintaining a strong infrastructure foundation continues unabated to build more resilient and thriving societies, fostering economic prosperity, and improving the overall well-being of communities in the state.

The comprehensive road infrastructure has significantly reduced travel time and expenses, allowing people to traverse the entire state within a few hours by vehicles. Twenty new national highways spanning 1130 km have been declared in the state, with eight projects already completed and 12 currently underway. This has ensured that every district in the state is now connected to the National Highway network.

#### **Minimizing delays**

In a strategic move to alleviate traffic congestion around the national capital Delhi, two expressways—Kundli-Manesar-Palwal and Kundli-Ghaziabad-Palwal—have been operationalized, provid-

### Rs 388-cr drinking water project

aryana Chief Minister Mr Manohar Lal on December 4, 2023 gave a big gift to Jind residents on the occasion of the birth anniversary of Saint Shiromani Sen Ji Maharaj as he laid the foundation stone of the project regarding providing drinking water from the Bhakra Main Line in Jind city.

The said canal-based drinking water supply project will be constructed at Rs 388 crore. This will increase the availability of clean drinking water to the Jind residents. The Chief Minister also inaugurated the Municipal Council Office building constructed at a cost of about Rs 15 crore.

In addition, various road widening and strengthening initiatives, such as the Jind-

ing efficient routes and minimizing delays for drivers. This initiative aims to streamline traffic flow in and around Delhi.

Furthermore, Ambala to Kotputli Greenfield Corridor (152-D) has been successfully completed at a cost of Rs 10,646 crore. This corridor facilitates rapid and smooth vehicular movement, allowing vehicles to cover vast distances in just a few hours. The completion of these infrastructure projects marks a significant milestone in enhancing connectivity and transportation efficiency across the state.

As road infrastructure serves as a fundamental component of transportation networks, facilitating the seamless movement of people and goods, the government has invested Rs 3,642 crore to construct 6,863 km of new roads, alongside improving 41,869 km of existing roads at a cost of Rs 21,133 crore.

Additionally, 17 toll tax barriers were removed to further facilitate smoother traffic flow.

To address specific traffic bottlenecks, strategic upgrades were made, converting PanchkulaHansi road, Jind-Bhiwani road, and improvements to several other roads, were inaugurated, amounting to crores in expenditure.

Furthermore, the Chief Minister also inaugurated Asan village Water Works for the smooth supply of drinking water in Asan and Shiva villages, which will cost approximately Rs 5.3 crore. The Chief Minister also sanctioned Rs 75.87 crore for augmenting sewage systems in different colonies of Narwana town.

The special maintenance of Jind-Julani Janjgir road, with an expenditure of Rs 3.82 crore, and the special repair of Jind-Safidon road connecting Jind-Rohtak via Jind-Gohana road crossing the Delhi-Bathinda railway line, costing Rs 3.85 crore, was also inaugurated.

Besides this, the approved metro rail projects from Narela to Kundli, HUDA City Centre-Cyber City Gurugram, and from Rezangla Chowk to Sector 21 Dwarka are poised to further enhance metro connectivity in the region, show casing the government's commitment to advancing public transportation.

## Rs 156.2 crore sanctioned for improving 11 highways

In a significant step towards enhancing connectivity and facilitating seamless transportation across Haryana, Chief Minister Mr Manohar Lal has granted administrative approval for improvement of 11 state highways at an estimated cost of Rs 156.20 crore.

Giving more information in this regard, an official spoke sperson said the project include Improvement of Rewari Pataudi road (SH-26) in Rewari District, covering 2.50 km with an estimated budget of Rs 1.73 crore, improvement of Rohtak Kharkhoda Delhi Border road (SH-18) in Sonepat district, covering 9.59 km with an estimated cost of Rs 10.75 crore and Lohani Kairu Obra Behal road (SH-5) in Bhiwani district, spanning 25.50 km at a cost of

Rs 25.17 crore.

The approval has also been granted to improve Hansi Tosham road (SH-12) in Bhiwani district, spanning 15.80 km at a cost of Rs 15.73 crore, Kala Amb Sadhaura Barara Shahbad road (SH-4) in Yamunanagar district, spanning 20 km at a cost of Rs. 11.11 crore and Improvement of Jind Barwala road (SH-10) in Jind district, spanning 7.15 km with an estimated budget of Rs 3.90 crore

Furthermore, the improvement of Kaithal Khaouri Road (SH-8), spanning 24.05 km with an estimated budget of Rs 10.11 crore has been approved along with Barwala Hisar Siwani Singhani road (SH-19) in Hisar, spanning 28 km has been approved with an estimated budget of Rs 26.36 crore.

### Gita Mahotsav opens with flair

#### Lord Krishna statue to be made with soil from 48 Kos

he sacred land of Kurukshetra, the cradle of Indian culture and the birthplace of the 'Shrimad Bhagwad Gita,' reverberated with divine convergence of spirituality, culture, and art as the International Gita Mahotsava started on December 7.

The grand event, during which the timeless teachings of the Shrimad Bhagwad Geeta have filled the air, would carry on till December 24 even as the Vice President Jagdeep Dhanka would inaugurate the main programme on December 17.

This time Assam has joined to actively participate as a partner state in the Mahotsav.

It was during his visit to Kurukshetra in 2014 that Prime Minister Sh Narendra Modi had expressed the commitment to make every possible effort to recognize Kurukshetra as a significant centre of the teachings of the Gita.

Following the Prime Minister's guidance, the Haryana Government has been organizing the Gita Mahotsav at the international level in Kurukshetra since 2016.

Since then it has been gaining tremendous success and popularity over the past seven years.

In 2019, the festival expanded its reach beyond the country, and was celebrated in Mauritius and London. Additionally, it took place in Canada in September 2022, and this year, there are plans to organize the International Gita Mahotsav in



the United States of America in April next year.

#### Fair authority to be formed

The Vice President will officially inaugurate the festival with Gita Yajna and worship at Brahma Sarovar on December 17. Later, he will also inaugurate the three-day International Gita Seminar at Kurukshetra University.

The seminar, scheduled to run until December 19, will witness the participation of Gita enthusiasts, scholars, and researchers from India and abroad. They will present their research papers on the theme of world peace and harmony, inspired by the teachings of Shrimad Bhagvad Gita.

Chief Minister Sh Manohar Lal, who has been monitoring the Mahotsav celebrations recently

informed that the International Gita Mahotsav Fair has been progressing towards financial self-sustainability.

In a strategic move akin to the organization of the Kumbh Mela, a dedicated fair authority will be established for the International Gita Mahotsav.

This autonomous body will independently organize and manage the event. The government will appoint a fair officer to oversee the arrangements, while the fair authority will take charge of planning and executing the festival.

The Chief Minister urged all the residents of the state to come together and recite the Gita shaloka collectively for one minute at 11 am on December 23, in honour of Gita Jayanti. During this brief session, participants would be encouraged to recite three verses from the Gita.

All citizens are invited to partake in this Gita lesson either from their homes or workplaces, with the option to connect through the Gieo Gita app for a shared experience.

#### **Crafts and Saras fair**

A Crafts and Saras mela on the banks of the holy Brahmasarovar has been a big attraction in the festival. This fair showcases the talents of nationally renowned artists and craftsmen.

A dedicated Haryana Pavilion, featuring folk dance, crafts, small-scale industries, and local cuisine, has been established to expose tourists and pilgrims to the rich culture of Haryana.

Additionally, exhibitions highlighting the development and progress of Haryana have been organized by various departments, providing valuable information about government welfare schemes and regional advancements.

The Mahotsava programmes will be held in every district for two days on December 22 and 23.

On December 23, a conference focusing on the pilgrimages within the 48 Kos Kurukshetra will take place at Kurukshetra University. Representatives from 164 pilgrimage committees in Kurukshetra will participate, bringing soil and water from their respective pilgrimages to later create an idol of Lord Krishna.

#### Gita recitation

On the same day, Gita Jayanti, a global Gita recitation will be led by 18,000 students in Kurukshetra. To commemorate Gita Jayanti, Deepotsav will be organized at all 164 pilgrimage sites in Kurukshetra on December 23.

The Chief Minister said that fun fair activities will be organized for devotees in the fair area from December 7 to 24. Students will have the opportunity to participate in various competitions, including Rangoli, clay modeling, Sanjhi, pot decoration, fancy dress, tableau, and poster making, scheduled from December 17 to 24.

To engage participants further, an online Gita quiz competition has been ongoing since November 26 and will continue until December 6.

Over 70000 citizens, including students, have registered for this online competition, reflecting the widespread interest in the event. In addition, a successful Gita Marathon was organized in Kurukshetra on December 3, further contributing to the festival's vibrancy.

### CM asks scientists to address agri issues

he Chief Minister, Mr Manohar Lal, has raised concern about the diminishing quality of crop production due to the excessive use of fertilizers and pesticides, leading to adverse impacts on human health, the impact of climate change, and asked agriculture scientists to address these challenges.

He was speaking after inaugurating the international conference on 'Strategies for Global Food and Nutritional Security, Sustainability and Wellness' (Nutri-2023) held on CCHAU campus. It is being attended by distinguished scientists from renowned research institutions across 14 countries.

#### **Significant strides**

Highlighting the significant strides Haryana has made in the agricultural sector, with its products being exported to many countries, he emphasized the collaboration between the state government and various coun-



tries worldwide to not only augment agricultural production but also enhance its quality. The Chief Minister said that concrete steps had been initiated for the uplift of the agriculture sector.

Incorporation of new technologies has led to remarkable achievements in the agricultural landscape, marked by record-breaking production. However, this success has

brought forth new challenges Laying stress on the pivotal role of scientists, he expressed confidence in the ability of the scientific community to overcome these issues and ensure a happier and healthier life for future generations.

Highlighting the emotional connection between the farmers of the country and the university, Mr Manohar Lal emphasized the crucial role played by the university's scientists in achieving self-reliance in the field of grains for the nation.

#### 900 from 15 countries

The three-day international conference has attracted participation from 900 scientists and researchers representing 15 countries, including America, Britain, Canada, Kazakhstan, Japan, Egypt, France,

Germany, Tunisia, Brazil, and Morocco. During the conference's inaugural session, Professor Arthur C. Redecker, cowinner of the IPCC Nobel Prize from France, and Professor Sergio C.

Caparada, a Faculty Fellow from Texas A&M University in America, delivered lectures on technical topics. Distinguished scientists from renowned research institutions within the country have also graced the conference with their lectures.

Earlier, the Chief Minister was apprised of the establishment of Agri Business Incubation Centre on the campus. It aims at fostering start-ups led by young entrepreneurs.

Over the past four years, this centre has facilitated initiation of 100 startups by disbursing a total amount of Rs 6 crore.

These have successfully employed tissue culture technology to develop superior varieties of banana, sugarcane, and processed food products derived from coarse grains.

## Graft is a cancer, eliminate it: CM

he cancer of corruption has a disproportionate impact on the impoverished, infringes on the rights of the poor, and deprives them of their due in society. This menace should be eliminated through collective social effort to propel the country and the state forward on the path of progress.

This was stated by the Chief Minister, Mr Manohar Lal, while addressing a programme on the International Anti-Corruption Day at the Public Works Rest House, in Panchkula, on December 9.

#### 16 officers honoured

Honouring 16 officers and employees for their exemplary work in combating corruption in the state, the Chief Minister acknowledged the global discourse on corruption and highlighted its pervasive nature worldwide.



Calling for the eradication of economic and moral corruption, Mr Manohar Lal likened the evil to cancer which would have fatal consequences. He urged the citizens to draw inspiration from figures like Lal Bahadur Shastri, Chanakya, and social worker Jagdish Ahuja. He lauded the commitment of the Prime Minister, Mr Narendra Modi, to maintain the image of the political community achieved through transparency in recruitment based

on merit. Speaking on the occasion, the Chief Secretary, Mr Sanjeev Kaushal, said corruption is a manifestation of dissatisfaction, jealousy, and inferiority complex.

Individuals with inferiority complex often engage in corrupt practices. The state government has utilized vigilance as a potent tool to eliminate corruption, offering over 600 citizen facilities and services through Saral Centres, linked to the auto appeal system, he added.

# Mission Karamyogi to skill 3 L employees

he Mission Karmayogi programme aims to impart moral lessons to the employees and officers of the state. Under this initiative, all 3.5 lakh employees and officers of the state will receive training by March 2023. The mission will help in eliminating corruption and fostering character development in the state.

This was stated by the Chief Minister on Anti-Corruption Day while virtually addressing the training programme being conducted at more than 25 locations in nine districts of the state under the Haryana Mission Karmayogi program.

The Karmayogi programme is raising awareness among the employees and officers, making them alert and motivated towards morality. This, in turn, enables them to play a crucial role in eradicating corruption, often referred to as the cancer afflicting the state.

Through the Karmayogi Mission program conducted via HIPAA, 967 master trainers have been prepared at the state level. They will consistently educate employees and officers about morality, duty, and responsibilities during their service.

The impact of this training will extend beyond their professional lives, influencing their social interaction and serving as a source of inspiration for the youth in the future. Under the Karmayogi Mission, 8622 employees and officers in the field have been trained on ethics and responsibility.

### Haryana floats new scheme to pat efficient officials

s a large number of administrative initiatives have been taken by the Manohar Lal government to add integrity and efficiency in governance, the state government, in a yet another novel initiative, has decided to reward officials who lead by example in good governance.

An official notification of the Haryana Good governance Awards scheme 2023 was recently issued by the state government, a step that would promote administrative excellence in big measure.

Chief Secretary, Mr. Sanjeev Kaushal said the Scheme had been designed with specific objectives, including the recognition and rewarding of outstanding contributions to good governance.

A grand awards ceremony is scheduled to take place on Governance Day, which falls on December 25, 2023, which also happens to be the birthday of former prime minister Atal Bihari Vajpayee.

Effort is to recognize and reward outstanding contributions to good governance initiatives at the state and district levels.

The scheme will apply to all employees in Groups A, B, C, and D across various departments, boards, corporations, statutory authorities, missions, societies, institutes, universities, and public sector undertakings under the State Government.

However, it would exclude Administrative Secretaries, Heads of Departments, All-India Service Officers and contractual manpower.

#### Flagship scheme awards

The state-level Flagship Scheme Awards will honour exceptional contributions to flagship schemes implemented by the state government. Winning teams will receive a trophy, an appreciation certificate signed by the Chief Secretary, and a cash reward of Rs. 51,000 per flagship scheme. The cash reward will be distributed equally among team members, regardless of rank or status.

#### State-level awards

The state-level awards will recognize exceptional performance in various initiatives and schemes even as the winning teams will receive a trophy, an appreciation certificate signed by the Chief Secretary, and a cash reward distributed as follows: 1st prize of Rs. 51,000, 2nd prize of Rs. 31,000, 3rd prize of Rs. 21,000. As with the Flagship Scheme Awards, the cash reward will be distributed equally among team members.

#### District-level awards

The district-level awards will recognize exemplary contributions at the district level. Winning teams will receive a trophy, an appreciation certificate signed by the Divisional Commissioner based on the recommendation of the Deputy Commissioner, and three cash prizes including first prize of Rs. 31,000, second prize Rs. 21,000, and third prize Rs. 11,000 will be distributed equally among team members.

#### **Economic sector**

The Subject areas of Commerce and Industries under Economic Sector includes Ease of Doing Business, Growth of Industries, Growth in MSME Establishments.

The Subject areas of Agriculture & Allied Sectors under Economic Sector includes Growth Rate of Agriculture and Allied Sector, Food Grains Production, Horticulture Produce, Milk Production, Crop Insurance.

The Subject areas of Environment under Economic Sector includes availability of Statelevel Action Plan for Climate Change, Change in Forest Cover.

The Subject areas of Economic Governance under Economic Sector includes Gross State Domestic Product (GSDP) Growth Rate, Growth in Per Capita Income, Fiscal Deficit as a Percentage of GSDP, State's Own Tax Revenue Receipts to Total Revenue Receipts, Debt (Total Outstanding Liabilities) to GSDP.

#### **Social sector**

The Subject areas of Human Resource Development under Social Sector includes Quality of Education, Retention Rate at Elementary School Level, Gender Parity, Enrolment Ratio of SC and ST, Skill Training Imparted, Placement Ratio Including Self employment.

The Subject areas of Social Welfare under Social sector includes Sex Ratio at Birth, Health Insurance Coverage, Rural Employment Guarantee, Unemployment, Housing for All, Economic Empowerment of Women, Empowerment of SCs, STs, OBCs, and Minorities, Disposal of SC/ST Atrocity Cases by Courts, Rights and Protection of Children.

The Subject areas of Citizen Centric Governance under the Social sector includes Number of Services Provided Through Electronic Format. The Subject areas of Judiciary and Public Security under Social sector includes Conviction Rate, Availability of Police Personnel, Population of Women Police Personnel, Disposal of Court Cases, Disposal of Cases by Consumer Courts.

The Subject areas of Public Health under Social sector includes Operationalisation of 24X7 Facility at PHCs, Availability of Doctors & Paramedical Staff at PHCs, MMR (Maternal Mortality Rate), IMR (Infant Mortality Rate), TFR (Total Fertility Rate), Immunization Achievement.

# 50 cyber crime hotspots in 7 states: DGP

n a major initiative to combat cybercrime, the Haryana Police have identified 50 hotspot areas across seven states in the country cyber fraud cases are known to originate from. To effectively tackle these cases, cyber teams have been deployed in these areas to not only control cyber fraud activities but also apprehend the perpetrators and bring them to justice.

Disclosing this, the Director General of Police, Mr. Shatrujeet Kapur, said that the maximum number of cyber fraud cases reported in Haryana originated from Rajasthan, with 21 identified hotspot areas in the state. Similar hotspots have been identified in other states, including Uttar Pradesh, Jharkhand, Delhi, West Bengal, and Telangana. Cyber teams are regularly dispatched to these states to actively counter cyber fraud activities.

Moving forward in the realm of cyber security, a collaborative effort is being undertaken by nodal officers of banks and the Cyber Helpline 1930 team.

This collaboration aims to freeze cyber criminals' finances within the critical first hour of reported incidents, working closely with bank personnel to facilitate the process.

Mr. Kapur urged the public to remain vigilant and avoid clicking on suspicious links on their phones.

Additionally, people must not disclose personal information related to their bank accounts to anyone. Even a minor oversight can make individuals vulnerable to cyber fraud.

## Free college education for girls

#### CM's missionary zeal to empower girl child

aking yet another leap forward to empower every girl child in Haryana the Manohar Lal government has taken a momentous decision of imparting free college education to girls coming from families with an annual income of Rs 1.80 lakh.

Making this announcement Chief Minister Sh Manohar Lal free education to such girls would be provided both in government and private colleges.

In addition, he also announced that the government would cover half of the college fees for girls from families with incomes ranging from Rs 1.80 lakh to Rs 3 lakh. The fees for private colleges, where applicable, will be borne by the Harvana Government.

The announcement is in line with various other initiatives that the Manohar Lal government has been taking from time to time to empower every girl child.

#### Vivah Shagun Yojana

The Haryana government has been making significant contribu-



tions through the Mukhyamantri Vivah Shagun Yojana, providing financial assistance to poor and needy families for the marriage of their daughters.

The Yojana was launched in October 2015 with the aim of providing relief to families living below the poverty line from the burden of marriage expenses.

Over the past more than eight years, an amount of Rs. 821 crore has been disbursed as Shagun for the marriages of 258,000 girls across the state.

In addition, the state government provides varying amounts ranging from Rs. 31,000 to Rs. 71,000, depending on different categories, to beneficiaries under the Vivah Shagun Yojana.

This Shagun amount is also provided to all families below the poverty line with an annual income of less than Rs. 1,80,000, supporting them during their daughters' marriages.

The scheme has now been expanded for all daughters in the family, whereas previously it was limited to two daughters.

Significantly, there is no need to repeatedly visit government offices to receive the marriage Shagun.

Instead, the amount is directly credited to the beneficiaries' bank accounts after they complete the online application process on the shaadi.edisha.gov.in portal and register their marriage.

#### Aapki Beti-Hamari Beti

The Aapki Beti-Hamari Beti scheme is another visionary step by the Manohar government wherein the government has provisioned an amount of Rs. 21,000 to be given to a girl child upon her birth.

Scheduled caste and economically weaker families receive Rs. 21,000 on the birth of their first girl child, while all other families receive the same amount on the birth of their second and third girl child.

This amount is deposited as a lump sum in the name of the daughter with the Life Insurance Corporation of India. When the daughter turns 18, she receives an approximate amount of Rs. 1 lakh.

#### Sukanya Samriddhi Yojana

Acknowledging the financial responsibilities associated with a daughter's education or marriage as she enters adulthood, he said that the government has taken a significant step by introducing the Sukanya Samriddhi Yojana.

#### HAU, IOC ink MoU to promote beekeeping
